Guidance notes

- (a) This form is only to be used for the purpose of obtaining a regularisation certificate in respect of works undertaken without a building permit as required by the Building Bye-Laws (Jersey). Planning permission may also be required for which a separate application should be made.
- (b) This form should be completed and submitted with one copy of plans and details showing the work as carried out, together with one copy of plans and details showing any additional work that is required to secure compliance with all relevant requirements in the second schedule to the building bye-laws.
- (c) Every application must include 1 copy of a location map, which must be an authorised copy of the 1:2500 scale ordinance scale map of the island.
The application site must be outlined in red. For domestic applications the site should be the house and its garden. Any adjacent land in the same ownership should be outlined in blue.
Photocopies of and/or versions of old maps will not be accepted, and all maps must have a valid copyright stamp or state a copyright licence agreement number.
- (d) The *Applicant* is the person or persons for whom the work is to be carried out.
- (e) *Floor area* means the aggregate of the areas of all floors in the building, or extended part, and is measured to the inner surfaces of the main enclosing walls.
- (f) *Charges for applications*; all applications must be accompanied by the appropriate fee. The fees payable for applications are set out in the department's fee schedule which can be downloaded from the States of Jersey website, www.gov.je, or collected from the department. Details of how the fee has been calculated must be shown on this form in the space provided. Cheques should be made payable to the 'Treasurer of the States'.
